- Homeowner from unit 86 informed the Board and management of Dog violations.

  - PRES to investigate options for installing energy efficient light bulbs on one of the buildings in the community.

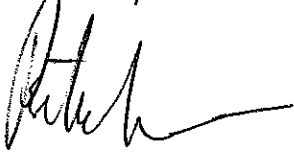
#### NEW BUSINESS
